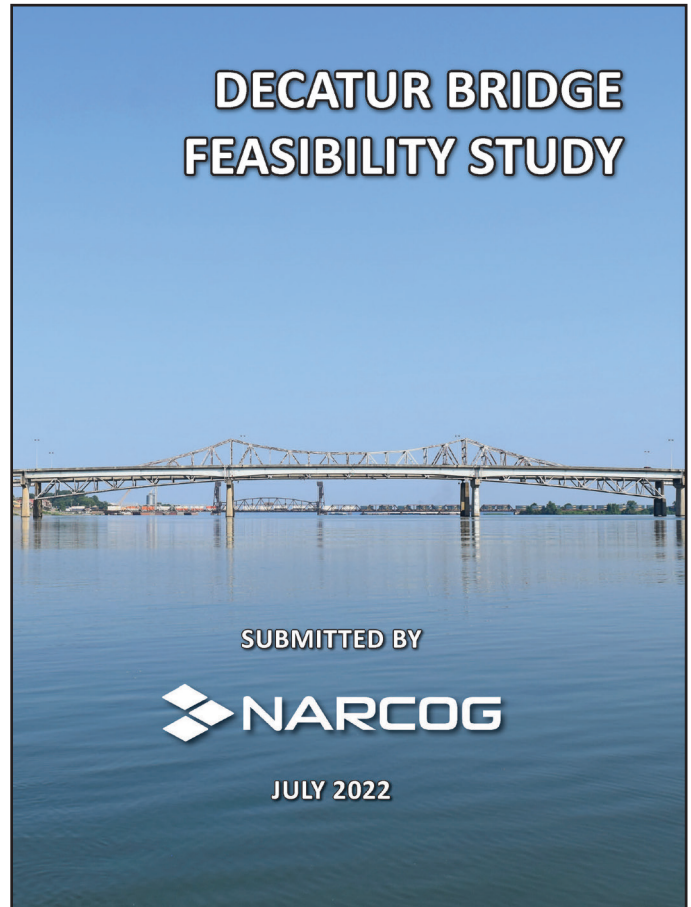
Decatur \$1M ARC SAAW Grant

City awarded \$1 million in funds for bridge feasibility study

The City of Decatur has recently been awarded a \$1 Million Appalachian Regional Commission (ARC) Southern Automotive and Aviation Workforce (SAAW) grant for a Decatur Bridge Feasibility Study.

The total cost of the study is \$2 Million. The purpose of the Decatur Bridge Feasibility Study is to assess the need for a new river crossing to replace the U.S. 31 southbound bridge over the Tennessee River, in the City of Decatur, Alabama. The construction of a new bridge over the Tennessee River is considered extremely important to ensure that the necessary transportation infrastructure is in place to support the continued growth of the Automotive cluster as well as the Aviation cluster in North Alabama. A new bridge will be an investment in "Building Appalachia's Infrastructure" and is a vital part of the Appalachian Development Highway System (ADHS) since it is part of Corridor V.

The Study will be data-driven to determine the need for construction of a new southbound Tennessee River bridge, which will meet the existing and future needs of the Automotive, as well as the Aviation employers of



North Central Alabama and the City of Decatur, Alabama, along with their employees and suppliers.

NARCOG Submits Three CDBG Applications for Nearly \$1.3M

NARCOG submitted three Community Development Block Grants (CDBG) grants in July for the Town of Colony, the Town of Garden City, and the City of Moulton. We are awaiting award announcements from Governor Ivey and ADECA in October, November, or December.

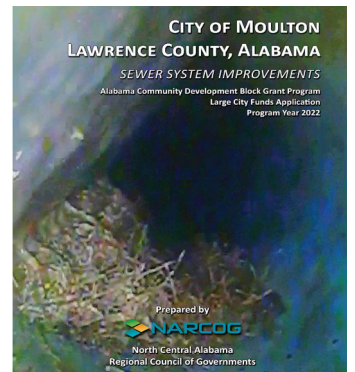
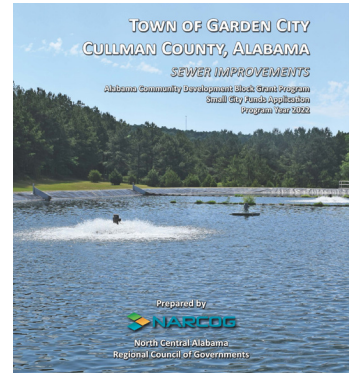
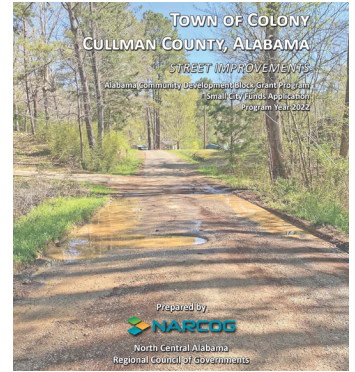
The Town of Colony submitted for \$399,827 in CDBG funds for the Colony Street Improvements project. The proposed Street Improvements project involves the rehabilitation of approximately 8,565 feet of paving along with patching and asphalt overlays on Johnson Circle, Ward Hill Road, and sections of Colony Road. The total square yards to be paved is 14,888. The roads do not have adequate ditching for stormwater drainage along the roads, so here will be 8,705 linear feet of drainage improvements required in the project areas as well to remove water from the roadway surfaces.

The Town of Garden City re-submitted for \$389,800 in CDBG funds for the Garden

City Sewer Improvements project. The proposed Sewer Improvements project provides benefit to 283 total people in 108 households, including 63 (57%) LMI households (160 persons). The urgent project will address the Alabama Department of Environmental Management’s (ADEM) non-compliance notification that Garden City received in April 2021, regarding the algae buildup in the sewer lagoon. This project will also remedy the E. coli recently found at the wastewater treatment facility. The proposed project consists of the replacement of three existing floating aerators, along with the associated electrical components, the replacement of two baffle curtains and the replacement of the emergency generator, along with the modernization of the associated electrical systems at the wastewater treatment plant.

The City of Moulton re-submitted for \$500,000 in CDBG funds for the Moulton Sewer Improvements project. The proposed Sewer System Im-

provements project involves the rehabilitation of approximately sixty-five (65) 4-inch diameter sewer laterals. Rehabilitation activities include: 1) hydraulic and mechanical cleaning of service connections; 2) post CCTV inspection; and/or 3) cured-in-place lateral sealing at the connection; and 4) installation of new laterals and mechanical service connections. The proposed project will improve the quality of life of a total of 184 beneficiaries including the 141 (76.6%) LMI persons that live in the project area located south of the historic downtown in Moulton. The project area is approximately bounded on the north by College Street and Somerville Avenue; on the west by Main Street and East Street; on the west by Rosenwald Street; and on the south by Byler Road along with several perpendicular streets to the south.

In her Grant Specialist role, Tiffany helps communities in the project development, preparation, submission, and management of a variety of grants through the ADECA CDBG and Recreational (RTP/LWCF) programs along with ARC. Some project examples include grants for infrastructure, such as water, sewer, storm water drainage, sidewalks, trails, and community facilities, such as parks, fire stations, community centers, senior centers, and educational programs and equipment.

Before coming to NARCOG, Tiffany worked as a print journalist, a preschool teacher, and secretary at a church. She has been married to her husband Zach for 12 years, who is a small business owner of Triple O Pest Control; they have two children, Mariah, age 21 and Tillman, age 11 who is a 5th grader at West Elementary. NARCOG completes five-year CEDS plan



The NARCOG Regional Planning Agency just completed the new Building for the Future 2022-2027 Comprehensive Economic Development Strategy (CEDS) for Cullman, Lawrence, and Morgan counties.

As the designated Economic Development District (EDD) by the Economic Development Administration (EDA), NARCOG is required to update its CEDS every five years. The new 2022-2027 CEDS goals consist of:

1. Build Resilient Regional Businesses
2. Build a Resilient and Sustainable Regional Economy
3. Build a Resilient Regional Workforce Ecosystem

4. Build Resilient Infrastructure for the Region

5. Build a Resilient Regional Tourism Based Economy

6. Build Resilient Regional Community Leaders and Capacity

NARCOG Regional Planning Agency will continue working with the CEDS Strategy Committee and other partners to implement the CEDS in the three-county region during the next five years.

The Decatur Bridge Feasibility Study will include site identification and site assessment based on various physical and environmental factors such as location, highway

and rail access, surrounding land uses, and the estimated cost of development amongst others. Once the most feasible site is identified, a detailed cost estimate, estimat-

ed economic impact (cost-benefit analysis), and potential funding sources, stakeholders, and partners will be identified to aid in moving the construction of a new bridge

forward. The City will be issuing a RFQ soon to select a consultant to prepare the study, and the estimated time for project completion is approximately one-year.
